
Terms of service - PolymathPlus

General

Welcome to the "PolymathPlus" website (hereinafter: "the website"). The website is managed and operated by the company "PLMTPlus LLC". (hereinafter: "Site management" or "the company"). The use of the website is subject to what is detailed in this document. Please read the website's terms of use (hereinafter: "the terms"). Your entry to the website and your use of it will indicate your agreement to the conditions listed above.

The site serves as a math equations solver platform that offers (among other services) an interface for solving complex mathematical equations (hereinafter: the "Services").

The website terms refer to the website that appears under the domain name <https://polymathplus.org/>

Wherever in these terms the term "surfer" or "user" appears, it refers to a person or company that uses the "PolymathPlus" website, whether through the Internet or through any other network or means of communication.

In some sections of the site, there may be additional terms of use and/or conditions, referring in detail to that section or service. The use of these sections and services is subject to both these terms of use and the individual terms and agreements to be found therein.

Wherever there is a contradiction between what is written in these terms and what is written on the website, the parties will consider only what is written in the terms already in effect.

The management of the site will be entitled to change the terms of the site from time to time without the need to give advance notice and the users of the site are responsible for keeping up to date with the changes. The company may at any time, at its sole discretion, update these terms.

The company and the website management do their best to present the most complete and comprehensive information about the product. Notwithstanding what is stated in this section, it will be clarified that inaccuracies and/or errors and/or omissions may appear on the website in good faith and without malicious intent and/or out of a desire to mislead, and the company, the management of the website and the website will not bear any responsibility arising from the inaccuracies and/or errors.

The titles of the chapters are given for the convenience and orientation of the customer and will not be used in the interpretation of the terms.

A clerical error in the description of the product(s) will not obligate the company.

The website management may from time to time require additional identification information.

The information on the website

"PolymathPlus" is a content site operating on the Internet. As mentioned, the site management has the sole discretion to decide which contents will be displayed on the site, the length of time they will be displayed, what their location and design will be, and any other matter related to their placement on the site.

The management of the site will not be responsible for any direct or indirect damage, financial or otherwise, caused to such person as a result of using and/or relying on the services and the data appearing on the site or on the information and content appearing on it.

For the avoidance of doubt, it is hereby clarified that the contents appearing on the site are at the sole discretion of the site management.

The management of the site undertakes towards the participants confidentiality in relation to their details which are not intended for publication, including details and means of payment (if they are transferred to the management of the site), and email details. However, the management of the site will not bear any responsibility in the event of a hacking of the site's database and misuse of the details contained therein.

Notwithstanding the above, the website management will not be responsible for any damage of any kind, indirect or direct, caused to the participant or any other party, in the event that the information reaches a hostile party and/or is used without permission either intentionally or through negligence.

By registering on the "PolymathPlus" site, you give permission to the site's management to include in the list of site customers who are included in its direct mail distribution.

The site management will be entitled to disclose the user's information in any case of a dispute or legal proceeding between it and the user.

Without detracting from the above, all the data provided by the website users that are not included in the scope of confidential information shall be usable, copied, distributed, publicly performed, granted permission to a third party, published or translated and the user hereby waives any claim regarding this information presented on the site.

Services that require registration

On the "PolymathPlus" website you can find services that require registration. You will be able to benefit from these services after completing the registration process, providing the details requested during registration, and receiving your consent to the online agreement accompanying the registration.

The use of some of the services that require registration involves paying a subscription fee. The instructions relating to the payment of the subscription fees will also be found in the online agreement accompanying the service, which you will be asked to confirm.

When registering for the service, you will be asked to provide personal details such as: first name, last name, and email address. Your credit card details will also be required (if the service involves a fee) as well as an active e-mail address in your possession. You must provide only correct, complete and accurate details and you hereby confirm the correctness of the details you provided. Incorrect details may prevent you from continuing to register and use the service.

It will be clarified that the data you provided when you registered for the service will be stored in the database owned by "PolymathPlus". "PolymathPlus" may not allow you to use the service that requires registration and this at its sole discretion.

Payment for services

Payment for the products will be made through a credit card or through an account in an "e-wallet" service such as PayPal (WWW.PAYPAL.COM) and any similar service, as will be available for use on the website, from time to time at the discretion of the website management.

If the orderer chooses to use a credit card to make the payment, the orderer will be asked to provide the credit card details, ID card, card type and validity. If the customer decided to pay via PayPal (WWW.PAYPAL.COM), the company will be able to collect the payment for the products only after receiving approval from PayPal. The use and receipt of authorization from PayPal are subject to the terms of use of the PayPal website.

The site management reserves the right to stop the use of any payment method on the site, to allow the use of additional payment methods and to apply different payment arrangements to different types of credit cards or payment methods that the site management will respect.

After the payment details have been entered in the online order form, the orderer will be sent a confirmation via e-mail that the order details have been received. It will be clarified that this confirmation does not obligate the website management to deliver the ordered products and it only indicates that the order details have been received by the website management.

After placing the order, the website management will check the payment method used by the customer, the orderer will specify on the "PolymathPlus" that he has paid the invoice and the management will check the validity of the invoice payment.

In the event that the transaction has not been approved by the credit company or by the PayPal account or any other means of payment available at the time, the orderer will receive an appropriate notification of this and the website management will contact the orderer in order to complete or cancel the transaction.

Cancellation of purchase by the ordering party

The customer may cancel the transaction in accordance with the provisions of the Consumer Protection Law and the regulations established pursuant thereto. Without derogating from:

Cancellation will be made only by written notice to the email address of PolymathPlus which will be specified on the company's website.

The cancellation of the transaction by the customer is subject to the presentation of an argument by the customer to the website management, the cancellation will be made in written coordination with the company management and with its approval.

Cancellation of purchase by the company

The company shall be entitled, at its sole discretion, for any reason, and at any time, to cancel or terminate a transaction and/or sale and/or cancel an order, in whole or in part, and/or the activity of the website, in whole or in part.

Notice of such cancellation or suspension will be given to the user or the orderer, and the company will refrain from charging the orderer's credit card or refund any amount paid for the products, to the extent that it was paid.

The provision of the service

In Firefox (version 24) you can block all cookies by clicking on "Tools," "Options," "Privacy," and selecting "Use custom settings for history" from the drop-down menu, then canceling the "Accept cookies from websites" option;

In Chrome (version 29), all cookies can be blocked by going to the "Personalization and Control" menu, then clicking on "Settings," "Show advanced settings," and "Content settings," then selecting the "Block websites from setting data" option Under the heading "Cookies."

Blocking all cookies will have a negative impact on the usability of many websites. If a user chooses to block cookies, he will not be able to use all the options on the website properly.

In addition, the user will be able to delete cookies already stored on the device he uses to access the website, for example:
